Overview

Are flammable storage cabinets safe?

Flammable storage cabinets should be used for all labs that use flammable chemicals. No more than 10 gallons of flammable chemicals can be stored outside of a flammable cabinet. The cabinet design must meet National Fire Protection Association (NFPA) 30 & Occupational Safety and Health Administration (OSHA) 1910.106 standards.

What if a chemical is leaking from a storage container?

Hazardous materials, including biological, chemical, and radiological substances, can threaten health and safety if they leak or spill from their primary storage container. Regulatory agencies such as the Environmental Protection Agency (EPA) and the Occupational Safety and Health Administration (OSHA) set strict regulations for chemical storage.

Is chemical storage safe?

Specific federal regulations require safe chemical storage to protect humans, animals, property, and the environment. Hazardous materials, including biological, chemical, and radiological substances, can threaten health and safety if they leak or spill from their primary storage container.

Can flammable chemicals be stored in a refrigerator/freezer?

Do not exceed the listed storage capacity of the cabinet. Keep cabinet doors always closed and secured to ensure proper functioning of the cabinet. Flammable chemicals requiring refrigeration must be stored in refrigerators/freezers that are explosion proof and appropriately rated for the storage of flammable materials.
