

# Lithuania s solar panel export tariffs







### **Overview**

What is the highest export tariff for solar panels?

The highest export tariff currently on offer is the Solar Savings Exclusive tariff from Good Energy, which pays 40p/kWh; however, it's only available to customers who have bought both solar panels and a battery from Good Energy Solar or JPS Renewables. More on: The Smart Export Guarantee explained.

How much can you get paid for exporting solar panels?

The amount you can get paid for exporting energy from your solar panels varies from a paltry 1p to 40p per kWh. That means that if you've got solar panels, choosing the best export tariff could earn you hundreds of pounds extra in payments every year. Looking at the latest available offers in April 2025, we found that:.

What tariffs does good energy offer?

Good Energy offers two export tariffs for customers with solar panels, rewarding them for the electricity they export to the grid. This variable tariff offers a premium rate of 40p per kWh for customers who have had both solar panels and battery storage installed by Good Energy.

Do you qualify for a low solar tariff?

Some energy companies have introduced temporarily high tariffs designed to persuade customers to go solar with them. To qualify, you have to get your solar panels and battery through the supplier – but once the initial 12-month export contract ends, you'll be rolled onto a lower tariff.

How much does a solar & battery tariff cost?

This tariff offers a 25p per kWh rate – but there are many strings attached. First, you have to pay for a solar & battery installation carried out by either Good Energy Solar or IPS Renewable Energy – which the supplier acquired in



2024 - and sign up to a Good Energy import tariff, too.

How do I apply for a solar export tariff?

Here are the eligibility criteria: First, fill out the company's online application form. Once you've pressed submit, someone from Good Energy's export tariff team will contact you to discuss the next steps. Or if you don't want to apply online, you can email solarsavings@goodenergy.co.uk or call 0345 034 2400 to start the process.


